CMGT 2810 – CONSTRUCTION PROJECT MANAGEMENT

COURSE DESCRIPTION

This course allows students to work in groups and put into practice aspects of project estimating, planning, scheduling, and participation in various leadership roles in the construction industry. It is designed to utilize knowledge from all other construction management courses on a final capstone project. Students will utilize PowerPoint, Excel, Word and Microsoft Project software programs to assemble their project presentation.

CREDIT HOURS: 3

Prerequisites: CMGT 1410, CMGT 1450, CMGT 2540 and CMGT 2670

COURSE OBJECTIVES

1. Students can use PowerPoint, Excel, Word and Microsoft Project software programs to create a final project.
2. Students will learn how to establish a construction company and become aware of the various legal responsibilities associated with operating that.
3. Students will create company names, logos, mottos, and mission.
4. Students will have the opportunity to practice different roles required in running a construction.
5. Students will assemble and present a final project showcasing the skills and knowledge they have obtained from all of the other construction management

GRADING

Students will be given work in class to be completed outside of class. Grades will be based on the quality of two (2) presentations and the understanding of work required and class attendance.
