

# CSIS 1070 – Living in a Digital World

## Textbook

No required text. All reference material comes from Open Educational Resources (OER) available on the web.

## Prerequisite

## Description

This course examines current business and communication tools needed to prepare learners for a changing technological world. The course will explore social platforms, the Internet of Things (IoT), privacy and security, organization tools, communication tools and strategies (including rhetorical strategies), website development, audio and video editing, digital meetings, and biases.

## Learning Outcomes - Students will be able to:

1. Create digital content using communication strategies.
2. Evaluate and use digital communication methods.
3. Adapt communication and reasoning practices to diverse audiences.
4. Analyze biases and assumptions (personal and others'), and their effects on personal, professional, and civic communication practices in the digital environment.
5. Implement intrapersonal and interpersonal skills to navigate the digital world.
6. Analyze the use of Internet of Things in technology.

## Grading

1. **Assignments (30%)**: The specific assignment, due date, and turn-in procedure are all managed through Canvas. Late work will be accepted after the due date, but a **10% penalty** will be charged.
2. **Discussions (50%)**: Participate in weekly discussions. Late work will be accepted after the due date, but a **10% penalty** will be charged.
3. **Final (20%)**: Each module will have a reflection paper for the student to reflect on what was learned in the module, this is in place of exams.
